Available to any customer primarily engaged in a business activity where a 1 ½" or larger sized water meter is required to provide adequate capacity to the unit(s) such as, but not limited to, large retail centers, restaurants, laundries, medical or professional complexes, and trade services served by the water distribution system of Riviera Utilities subject to the pertinent provisions of the Utility's Rules and Regulations. Effective for all billings of this rate class rendered on or after May 1, 2024.
